
# 2022 INDIANA DENTIST WORKFORCE

About the Data in this Brief: In Indiana, dentists are licensed and regulated by the Indiana State Board of Dentistry at the Indiana Professional Licensing Agency (PLA). Indiana's dentists provide information on their demographic, education, and practice characteristics through a series of supplemental questions that are embedded within the online license renewal process. These data are critical to monitoring trends in the oral health workforce and identifying gaps across the state. As such, dentists renewing license renewal online are required to provide key information to inform State policy and planning.<sup>1</sup>

NOTE: Dentists completing their renewal manually (on paper) do not receive the supplemental survey questions.

Indiana Dentist Workforce Trends: The figure below depicts the trends in total Indiana dentist licenses, total respondents to the supplemental questions and total providers that were included in the reporting sample as designated in the Indiana Dental Workforce Data Reports from 2016 to 2022.2 Trends in total dental licenses, online survey respondents, and reporting sample of Indiana dentists demonstrate increases until the latest renewal cycle. While additional investigation is needed to determine specific reasons for recent trends, the COVID-19 pandemic likely contributed. These trends are concerning as Indiana falls behind the nation in dental workforce capacity with approximately 47 dentists per 100,000 Hoosiers, as compared 61 dentists per 100,000 population nationally.3

### Indiana Dentist Workforce Trends



In 2022, 4,054 dentists renewed their Indiana license. Of those renewals, 3,627 (89.5%) were active licenses that were renewed electronically. The remaining 10.5% (427) of dentist license renewals were either inactive licenses or professionals that renewed manually (paper application) and did not have supplemental questions administered. Of note, there was a greater frequency of offline renewals compared to previous years, which likely contributed to the reduced counts in the reporting sample.<sup>4</sup>





# **INDIANA DENTIST: DEMOGRAPHICS & EMPLOYMENT**



The Takeaway: Indiana's dentist workforce is younger and more diverse than previous years. Female dentists tend to be younger and more diverse than their male colleagues. Most dentists report they intend to continue practicing at the same capacity in the next two years.






The Takeaway: The majority of Indiana dentists are trained in Indiana. Just under one third of dentists reported completing a residency. The number of dentists reporting serving as a dental educator (academia) has been decreasing.





# **INDIANA DENTAL FACULTY LICENSE**

As of 2022, there were 10 individuals who held a Dental Faculty license. 1 This license is granted to individuals whose practice is limited to a school where they are employed and have research or teaching responsibilities.2

# **INDIANA DENTAL INSTRUCTOR LICENSE**

Indiana also issues instructor licenses to individuals who are not licensed to practice dentistry in Indiana but have been licensed for 5 of the preceding 9 years to practice dentistry in the United States or another country, territory, or other recognized jurisdiction. There are additional requirements set forth in code to obtain the dental instructor license.3 As of 2022, there were 11 individuals who hold a dental instructor license.1




## INDIANA DENTIST: PRACTICE CHARACTERISTICS



The Takeaway: The majority of Indiana dentists (84.4%) report practicing in an office/clinic setting, which is defined as either a solo, group, or partnership practice. This is a slight decrease from 2020 numbers because a new setting category was added in 2022: Dental Service Organization (DSO), which captured 9.1% of dentists. Only a few dentists offer teledentistry services.<sup>1</sup>

# INDIANA DENTIST PRACTICE SETTINGS – WHAT'S NEW?

For the 2022 renewal period, the Oral Health Workforce Data Advisory Group suggested inclusion of an additional dentist practice setting option: Dental Service Organization (DSO). In comparing 2022 responses to 2020, response frequencies suggest that many dentists now reporting a primary practice of a DSO may have previously self-categorized their practice setting as a "Dental Office."




# **INDIANA DENTIST: PRACTICE CHARACTERISTICS (CONT.)**



The Takeaway: Most dentists report serving in a general dental practice. More dentists report being engaged in telehealth services compared to recent years, though the total number of dentists providing telehealth is small compared to other health professions.

# TELEHEALTH VS. TELEDENTISTRY

Teledentistry is not defined in Indiana Code or Indiana Administrative Code, but oral health professionals were included in the definition of telehealth in Indiana through a 2021 bill. <sup>1</sup> The American Dental Association and Indiana Dental Association have provided guidance related to telehealth in dentistry.<sup>2</sup>

Although 7.6% (223 dentists) may seem like a small proportion of the workforce, this is a large increase from 2020 when only 49 individuals or 1.6% of dentists reported providing this service. An increased engagement in telehealth has been identified across numerous health professions and may be related to practice adaptations during and post-COVID.



# INDIANA DENTISTS: CAPACITY AND GEOGRAPHIC DISTRIBUTION





# 2022 DENTAL HYGIENIST WORKFORCE

**About the Data in this Brief:** In Indiana, dental hygienists are licensed and regulated by the Indiana State Board of Dentistry at the Indiana Professional Licensing Agency (PLA). Indiana's dental hygienists provide information on their demographic, education, and practice characteristics through a series of supplemental questions that were embedded within the online license renewal process. These data are critical to monitoring trends in the oral health workforce and identifying gaps across the state. As such, dental hygienists completing license renewal online are required to provide key information to inform State policy and planning.<sup>1</sup>

NOTE: Dental Hygienists professions completing their renewal manually (on paper) do not receive the supplemental survey questions.

**Indiana Dental Hygienist Workforce Trends:** The figure below depicts the trends in total Indiana dental hygienist licenses, respondents to the supplemental questions, and providers that were included in the reporting sample (self-identified as actively practicing in Indiana) from 2016 to 2022. As evidenced by the trends, the number of dental hygienist license renewals, online survey respondents, and reporting sample of Indiana dental hygienists have seen a steady increase until 2022. The decrease in dental hygiene workforce is consistent with national health trends observed during and following the COVID-19 Pandemic and dentist reported difficulty in recruiting dental hygienists.<sup>2</sup>



In 2022, 5,019 dental hygienists renewed their Indiana license. Of those renewals, 4,766 (95.0%) were active licenses that were renewed electronically. The remaining 5.0% (253) of renewals were reflect individuals that are either 1) not actively practicing, 2) have inactive licenses, or 3) completed their license renewal manually (paper application) and did not have supplemental questions administered.




### INDIANA DENTAL HYGIENISTS: DEMOGRAPHICS & EMPLOYMENT




The Takeaway: The average age of Indiana dental hygienists is stable. Dental hygienists are trending toward more racial and ethnic diversity but remain predominately female. While most of the dental hygienists report plans to continue with their current employment, the percentage of hygienists reporting 1) plans to decrease hours, 2) leave patient care, or 3) uncertain about their future employment plans is increasing.




Age Trends among Indiana Dental Hygienists





# Trends in Indiana Dental Hygienist Racial & Ethnic Diversity




## **EMPLOYMENT PLANS**



Report Intersection: In 2021, a report was released related to the impact of the COVID-19 pandemic on Indiana dentists and dental hygienists. Dental hygiene was cited by Indiana dentists as the top "hardest to fill" position in their office.<sup>1</sup>




# INDIANA DENTAL HYGIENISTS: EDUCATION CHARACTERISTICS



The Takeaway: Dental hygienists have begun to report higher levels of educational attainment with more hygienists earning their baccalaureate degree in dental hygiene than ever before. Most dental hygienists trained in Indiana and report their primary field as direct patient care. Forty hygienists report serving in dental hygiene education.



Where do Indiana dental hygienist receive their qualifying education?




# **DENTAL HYGIENIST EDUCATORS**


Available data in Indiana and at the national level demonstrate that the dental hygienist workforce is experiencing an increased unmet demand for workers.<sup>2</sup> Dental hygienist is considered a high-demand occupation by the Indiana Department of Workforce Development, with a projected 11% increase in the workforce from 2016-2026.<sup>3</sup> To meet the growing need for dental hygienists, it is helpful to understand capacity of the dental hygiene pipeline. A first step to quantifying pipeline capacity is understanding the workforce of dental hygienist educators.


# INDIANA DENTAL HYGIENISTS: PRACTICE CHARACTERISTICS




The Takeaway: The majority of Indiana dental hygienists (88.7.%) report practicing in a dental office setting, which is defined as either a solo, group, or partnership practice. This is a small decrease from the 2020 report (94.2%) since capturing Dental Service Organization as a practice setting.




# TELEHEALTH/TELEDENTISTRY

Dental hygienists were included in the definition of telehealth in Indiana through a 2021 bill. The American Dental Association and Indiana Dental Association have provided guidance related to telehealth in dentistry.<sup>2</sup> The slower uptake of telehealth among dental hygienists may be due to a myriad of factors, such as recent policy change, limited guidance, reimbursement, or slow uptake of telehealth among dentists.




# DENTAL SERVICE/SUPPORT ORGANIZATIONS (DSOS)

"DSOs" originally referred to "Dental Service Organizations", but today this acronym stands for "Dental Support Organizations." DSO are entities that dental providers may use to assist with the business activities associated with a dental practice. In general, DSOs do not provide clinical services, as dental services are provided by or under the supervision of a licensed dentist. DSOs support provision of dental services by managing business activities and allowing dental professionals to concentrate on the clinical services.1-4

For the 2022 license renewal period, the Indiana Oral Health Workforce Data Advisory Group recommended including "DSO" as a response option for dentist and dental hygienist practice settings. However, with the shift in terminology from dental service organization to dental support organization, it might be more appropriate for DSOs to be incorporated as a type of business or employment arrangement, as opposed to a practice setting. The Bowen Center will work with the Advisory Group before the next license renewal period to determine the most appropriate mechanism to report on the rise of DSOs to support dental practices.

## PUBLIC HEALTH & SAFETY NET SETTINGS

Oral health is a critical component of primary care, which is increasingly being delivered in public health settings such as home health, local health departments, school-based settings, mobile units, correctional facilities, Indian Health Service sites, and other settings. 5 Many Indiana oral health professionals work in these settings to meet the patient where they are at to deliver dental services. In total, there are 55 dentists and 37 dental hygienists who report providing dental services to Hoosiers in one of these public health settings. Below is additional demographic and practice characteristics for these public health dentists and hygienists.





# ORAL HEALTH WORKFORCE POLICY UPDATES

# 2022 SENATE ENROLLED ACT 136 - DENTAL PLANS

#### What did it do?

- Prohibits a dental plan from requiring a dental provider to provide a dental service to covered persons at a free rate that is:
  - (1) set by the dental plan or
  - (2) subject to the approval of the dental plan
- Unless the specific service is a covered under a dental plan, prohibits a third-party from arranging a provider to provide services for a dental plan that sets the fee rate for any dental services unless the services are covered services under the dental plan.

# 2023 SENATE ENROLLED ACT 273 - ADMINISTRATION OF ANESTHESIA IN DENTAL OFFICE

#### What did it do?

- Provided that a rule requiring an office-based setting to be accredited by an accreditation agency does not apply to certain individuals providing anesthesia in a dental office.
- Allows an anesthesiologist, a certified registered nurse anesthetist, and an anesthesiologist assistant to administer moderate sedation, deep sedation, or general anesthesia to a patient in a dental office if certain standards are met.

# 2023 HOUSE ENROLLED ACT 1113 - DENTAL COMPLIANCE FUND.

#### What did it do?

- Removed a requirement that dentists and dental hygienists pay a \$20 compliance fee during license renewal that is deposited into the dental compliance fund; thereby reducing cost burden for license renewal.
- Requires money in the compliance fund be used for administering and enforcing the provisions of the Indiana Code chapter concerning the regulation of dentists.

# OTHER INDIANA ORAL HEALTH WORKFORCE POLICIES THAT WERE CONSIDERED BY THE INDIANA GENERAL ASSEMBLY, BUT NOT SIGNED INTO LAW:

Modification of dental service reimbursement rates (2023 House Bill 1112)
Authority for dental hygienists to administer immunizations (2022 House Bill 1331)

# CHECK OUT THE INCENTIVE PROGRAMS THAT MAY BE AVAILABLE!

There are several federally funded, State-operated, and externally-housed incentive programs available to support Indiana dentists and dental hygienists. Most of these programs incentivize service in rural and underserved areas or specialties in Indiana.



Most federal and state opportunities require service in a shortage area. #### **FEDERAL OPPORTUNITIES:**



The federal government offers several opportunities through HRSA to strengthen Dental and Dental Hygienist education pipelines.

- <u>National Health Service Corps (NHSC) Students to Service Loan Repayment Program</u>: Supports dentists and dental hygiene students in their last year of training in exchange for service in an underserved area.
- NHSC Loan Repayment Program: Supports practicing dentists and hygienists providing care in underserved communities.



### **STATE OPPORTUNITIES:**

• The Indiana Department of Health operates <u>Indiana's State Loan Repayment Program</u> which offers dentists and hygienists up to \$20,000 per year to serve in certain geographies or settings throughout the State.



### OTHER OPPORTUNITIES:

• There are also numerous other incentive programs operated externally to the State of Indiana. For example, a <u>scholarship</u> is available through the IUPUI-IU School of Dentistry to support students from diverse backgrounds. IU Northwest also has several <u>scholarships</u> available to support undergraduate dental hygiene students. Additional incentive opportunities may be found on the <u>Bowen Portal</u>.
