**THREAT ANALYSIS**

***Excessive heat warning remains in effect until 8 pm EDT Saturday***

The combination of temperatures in the 90's, and high humidity, will produce dangerous heat index values of around 105 degrees to 115 degrees from early afternoon into early evening each day during the warning period. The impacts of heat stress are cumulative and increase each day the heat lasts. Anyone spending significant amounts of time outdoors or involved in strenuous activity will be susceptible to serious and potentially life threatening heat illnesses. A KNOZONE action day has also been declared in Marion County today.

**ACTION STEPS**

***The Marion County Medical Multi-Agency Coordination Center (MedMACC) will be activated at a higher level today in response to the excessive heat warning***
